Subjective directions of the conference:

Requirements for abstracts:

1. The text of abstract in volume 1 or 2 **full** pages should be typed on one side of a sheet of A4 format in the editor Microsoft Office Word version 2003-2016; font - Times New Roman; size – 12pt; line spacing - 1.1; All margins- 2 cm.

2. Abstracts must be published for the first time, be prepared in concise scientific language, contain all the necessary attributes of scientific publication, as shown below:

Example of abstract:

NAME OF MATERIALS WITH BOLD CAPITAL LETTERS

Name and initials of authors (Petrov A.V., Smith J.) - italics*

Name of company, city (eg.: JSC «Enterprise», Kharkov)

* Name of company n, city (eg.: LLC «Enterprise_n», Kyiv)

In a blank line the text of the abstract in font Times New Roman with 1,1 spaces between lines and tabulation of 1.25 cm at the beginning of each new paragraph.

Links to information sources should be made in the text in short form without the imposition of sources at the end of the text. The thesis should include a brief description of the problem to be solved, justifying the relevance and purpose of research, research subject and problems, author's (s') own suggestions, expected or actual practical significance of the proposals, conclusions and recommendations for further research. The material must be logically constructed and be a short but meaningful message about one of the topical issues in the field covered by directions of the conference.

3. Figures should be inserted in the abstract text in formats JPG, TIF, GIF. For mathematical formulas it is preferably to use the Word's built-in Editor MS Equation.
